## TRAVEL DIRECTIONS

**FROM THE NORTH** – Take the Garden Sate Parkway south to Exit 37 Washington Ave. At the light, turn left onto Washington Ave, go under Garden State Parkway. At next light, turn Right (Fire Rd.). At next light (Rt. 40) turn Left (towards Atlantic City—East) and go approximately 3 miles to the Dunkin Donuts, just past St. Peter's Church. Turn Right onto Main Street at the Dunkin Donuts and go 4 blocks to Bayview Ave (Cedar Market) and go East (left) to the Bay.

**FROM THE SOUTH** - Take the Garden State Parkway north to Exit 36 N. Turn left onto Fire Road and go to the 3<sup>rd</sup> traffic light (Rt. 40). Turn Right (towards Atlantic City-East) and follow the directions on Rt.40 in the section FROM THE NORTH.

**FROM THE WEST -** Take Atlantic City Expressway to Exit 7 S (Garden State Parkway –South) and follow the directions in the section FROM THE NORTH. Alternate route: Take Route 40 (Black Horse Pike) east to Pleasantville. Turn right onto S. Main St. on the right.
