I, on behalf of myself and my child (if applicable), agree to indemnify, defend and hold harmless Hadassah from any and all claims, liability, damage, cost, loss and expense (including attorney's fees) arising from, related to, or in connection with my and/or my child's (if applicable) participation in the Event, my and/or my child's (if applicable) travel to, during and from the Event, any property damages, loss or theft caused or participated in by me and/or my child (if applicable), any negligence and/or intentional act on the part of Hadassah or any other person or entity, and any bodily, emotional or mental injury, illness, disease or death caused or participated in by me and/or my child (if applicable).

I agree that this Consent, Release and Indemnification is to be solely and exclusively governed by and construed in accordance with the laws of the State of New York without giving effect to principles of conflicts of law. I hereby consent to the exercise of exclusive personal jurisdiction of the courts in the State of New York and the federal courts sitting in New York in connection with any matter arising from, related to, or in connection with the Event. This consent, release and indemnification is intended to be as broad and inclusive as permitted by the State of New York, and if any term or provision hereof is declared invalid by a court of competent jurisdiction, the remaining terms and provisions shall remain unimpaired and in full force and effect.

I acknowledge that I have read and understand this Consent, Release and Indemnification and that it shall be binding on me, on behalf of myself and my child (if applicable), and my and/or my child's family members, next of kin, heirs, representatives, successors and assigns.
